# 11. Department Heads:

**Ann Peterson, Payroll / HR Coordinator:** Temporary Truck Driver Jim Pann's last day was Friday, February 17<sup>th</sup>, as he was called back to his full-time job. He will not be replaced at this time.

A mileage reimbursement spreadsheet was made available for commissioner review showing the increase in mileage from \$0.625 to \$0.655.

**Tanya Hoar, Finance Director:** Per request at the last meeting, a spreadsheet was provided outlining all IT Expenses, including annual subscriptions, internet, hardware, software, support, etc. T. Hoar provided an overview, along with 2023 projected expenses. It was noted that SCRC IT expenses for 2023 are projected to be about 0.27% of revenue.

**Roger Martin, Shop Foreman:** Provided an update regarding B-289, the 2004 Peterbilt that broke down. He noted that it will need a new transmission. An estimate in the amount of \$15,676.53 was included (\$16,408.32 less sales tax of \$731.79).

- 13. Public Comment: Commissioner K. Rochefort asked if temporary truck driver wages will be increased based on the increases agreed on through contract negotiations for full-time drivers. They currently earn \$19.00 / hour and a 2% increase is budgeted for 2023, increasing the wage to \$19.38 / hour. T. Hoar provided figures based on a 2% increase. Commissioner T. Klarich noted that the cost-of-living adjustment is currently about 8.8%. T. Hoar will acquire benchmark data from other road commissions and report back to the board.

Commissioner R. LaCroix asked about hand-held radios. R. Martin noted that all drivers will be issued the hand-held models and we will be moving to these rather than the current radios.
