9. Manager's Report

- Per my conversation with Nancy Roseman the master agreement gives us permission without permits to perform work on the listed forest roads in the master agreement. There is no reimbursement from the forest service for the roads except for certain construction projects and if the road is a shared road and with prior approval from the forest service. Nancy believes the share to be 80/20 (80 forest service; 20 road commission). In some cases, forest service roads will have permits for snow removal operations and those permits are generally for the landowners. In the case of FR2180 she believes that it was added to Alger CRC master agreement, so they could do the snowplowing rather than the landowners having to take care of it with a permit. The reason we collect the funds and pay Alger CRC is because the landowners are all in Schoolcraft County. It is an access road to our local road. The landowners pay because Alger does not want the burden of cost for a road that serves no purpose to their county. Nancy is confirming, but she believes there is nothing that says the landowners can't pay for this portion of the FS road to be plowed, because if they were to get a permit from the Forest Service, they (landowners) would have to pay to have a private company plow the road.
- b. Gravel crushing RFP's have been sent to Brow Crushing, Northfork, Hartman's, Zellar's, Northstar, and Associated along with being posted in the Tribune and on our website. Bid opening January 23, 2019.
- c. Mueller township voted and passed the resolution opposing SB 396. I provided them with their requested information on the traffic counts that were previously completed for type of vehicles that passed over the traffic counters
- d. All of our projects were approved, and Peter has provided me with Job #'s for the 2 chip seal projects for 2019. I have sent that information on to Tony, so we can try to get an early bid letting.
