#### g. Financial Statements

T. Hoar reported that cash increased by ~\$300,000 from September primarily due to the special State funding that was received in October. The format for the Statement of Activities was revised to allow better financial analysis. The new format includes the annual budget broken down by month for a better comparison to actual performance. The month of October has a ~\$265,000 profit compared to the budget amount of \$365,000. Most of the difference was in the fringe benefit line item. The variances in fringe benefits are in expense account that have high variability from month to month.

### 9. Managers' Report

- a. I came across some letters that were received from concerned citizens in 2016, when it appears that the road commission was and/or did remove private plowing services. The biggest concern appeared to be with the timeframe in which the public was notified of said changes in services. If the Board is going to consider stopping all private services for the 2019/2020 winter season, I think it is in the best interest that the decision is made soon, and the public is notified early and then again in the fall. I suggest that we also notify the private companies, so they can decide if they want to ramp up their advertising. That was another concern in 2016 was that they didn't know who to contact for plowing services.
- b. To complete the process of implementing the seasonal county road system properly we will need to hold a public hearing. I suggest we hold the public hearing at our January 9, 2019 regular meeting. This will allow us enough time per MCL 247.655a requirements of notice to be published not less than 30 days prior and second notice not less than 7 days prior to the public hearing. The resolution can then be presented at the January 23, 2019 for final adoption. I have a copy of the resolution for your review
- c. We received notification that bridge structure #9709 CR 448 over Stutts has been chosen as part of the local bridge program with grant money in the amount of \$425,000.00. I have sent the information to UPEA to start the process of design and permits. The bridge is slated for FY 2021.
- d. It is a top priority to get the RFP's out and in the local papers by the end of the month. Once I know I have all the details in place I will pick a date to have the bid opening and update the Board.

### 10. Department Heads

- a. K. Rochefort, road foreman, notified the board that winter operations are in full swing and that all was well with the crew.
- b. G. Dibble, shop foreman, notified the board that the mechanics are all being kept busy working on all of our trucks and winter equipment.
- c. J. Johnson, Seney foreman, notified the board that winter operations in Seney are in full swing and the guys are working hard to keep up.
- d. T. Hoar, financial director, is currently working on cleaning up our year end items and getting ready for our audit.

e. B. DeMars, human resources, is currently working on getting our revamped permits ready for our website. She has posted the fee schedule and is hoping to have everything ready by next month. Everything went well with the parade and she would like to take the opportunity to thank everyone who volunteered their time.
